

IMVERSE HOLO SOFTWARE | GENERAL TERMS AND CONDITIONS

These general terms and conditions (**GTC**) apply to and govern the use of IMVERSE HOLO software (the **Licensed Product**) made available by Imverse SA (CHE-465.460.314), Route de la Galaise 34, 1228 Planles-Ouates, Geneva, Switzerland, email: info@imverse.ch (**Licensor**) to you (**Licensee**).

IMPORTANT LEGAL INFORMATION: PLEASE READ THESE GTC CAREFULLY, AS LICENSEE MUST AGREE TO THEM BEFORE USING THE LICENSED PRODUCT, AND THEY CONSTITUTE A BINDING, ENFORCEABLE CONTRACT BETWEEN LICENSOR AND LICENSEE.

1. Scope and Acceptance

- 1.1 These GTC govern Licensee's rights and obligations with respect to the Licensed Product, including, but not limited to, any documentation related thereto, made available by Licensor to Licensee in any form.
- 1.2 These GTC do not govern any integration, support or maintenance services Licensor may provide, whether or not under one or more separate agreements. If, within the frame of such services, Licensor provides any bugfixes, patches, updates, upgrades, developments, or the like for the Licensed Product, subject to express written agreement to the contrary, they do, however, automatically become part of the Licensed Product governed by the GTC.
- 1.3 Any deviations and/or supplements to these GTC require the express written approval of Licensor for their validity. Such deviating agreements shall only apply to the agreement that contains the deviating agreement and shall not have any prejudicial effect for other agreements between the contractual parties.
- 1.4 Any General Terms and Conditions of Licensee are herewith expressly objected to. Their application to the contractual relationship between Licensor and Licensee is excluded.

2. Grant of License

- 2.1 Subject to Licensee's compliance with all provisions of these GTC, Licensor grants to Licensee a limited, revocable, non-exclusive, and non-transferable license, to use the Licensed Product, in the form of executable object code only, strictly in accordance with its documentation provided by Licensor, as may be revised or amended by Licensor from time to time at its sole discretion, on Licensee's behalf, and for Licensee's sole benefit (the **License**).
- 2.2 Licensee shall not use the Licensed Product for any unlawful purpose. Licensee must not copy, alter, modify, publish, sell, assign, sub-license, reproduce, reverse engineer, disassemble, decompile, create derivative works based on or otherwise exploit the Licensed product, directly or indirectly, in whole or in part, or allow, encourage or permit any other person to do so, unless expressly authorized by Licensor.
- 2.6 The right of use is limited to the number of usage units booked by Licensee in accordance with the

respective License. Any sub-licensing or further licensing of the License Product is prohibited. Licensee has no right to a copy and thus also no right to a backup copy of the License Product. All rights in the License Product over and above the rights of use defined in these GTC remain fully with Licensor.

- 2.7 Licensor has the irrevocable and unfettered right, in its discretion, to change and/or modify at any time the specifications and features of the Licensed Product. Licensor will use reasonable efforts to notify Licensee of each such change or modification.

3. Licensee's Account and Credentials

- 3.1 In order to download and install the Licensed Product and its functionalities, Licensee must create an online account with Licensor (the **Account**) and be logged in to the Account.
- 3.2 If Licensor issues user credentials on a named user basis, such user credentials shall be used exclusively by the individuals for which they have been issued, on behalf and for the benefit of Licensee. User credentials issued to Licensee without specifying the individual users may be used by any employees, agents and/or duly authorized representatives of Licensee, strictly on behalf and for the benefit of Licensee.
- 3.3 Licensee is fully responsible for the confidentiality of its password and any user credentials issued by Licensor, and for the use of the Account, and has a duty to immediately inform Licensor of any loss or unauthorized disclosure of such password or user credentials, which will then be deactivated and replaced by Licensor. Licensee shall further immediately notify Licensor if any named user for whom Licensor has issued user credentials quits Licensee's organization, in which case Licensor will deactivate and replace such credentials. Licensor may charge an appropriate fee for the replacement of any user credentials.

4. Third-Party Software

- 4.1 The Licensed Product may contain software incorporated into the Licensed Product or provided with it, developed, distributed and/or licensed by third parties, including, but not limited to, open source software (**Third-Party Software**). Such Third-Party Software will be licensed, and Licensee has a duty to use such Third-Party Software under, and strictly in accordance with, the applicable terms and

conditions by the respective third-party licensor. Licensor will use its reasonable, good faith efforts to identify any Third- Party Software in the documentation of the Licensed Product.

4.2 Additionally, any Third Party Software is subject only to any applicable warranties of their respective suppliers, and Licensor is not in any way responsible for anything of every kind and nature, now or later contemplated, in any manner relating to Third Party Software.

4.3 Nothing in these GTC restricts, limits, or otherwise affects any rights or obligations that Licensee may have, or conditions to which Licensee may be subject, under any applicable open source licenses, and/or to any open source software which may be incorporated in and/or provided together with the Licensed Product.

5. Intellectual Property

5.1 Licensor shall own and retain all right, title and interest in and to (a) the Licensed Product, all improvements, enhancements or modifications thereto, (b) any software, applications, inventions or other technology developed in connection with implementation services or support, and (c) all intellectual property rights related to any of the foregoing.

5.2 Licensee expressly acknowledges that any infringement, or other misuse of Licensor's intellectual property rights including, but not limited to, in and to the Licensed Product, or any alleged, actual or anticipated breach by Licensee of this Section 5, will cause irreparable harm to Licensor, for which monetary damages alone would be inadequate, and that Licensor is entitled to seek injunctive relief, or any other remedy available at law, or otherwise, in any jurisdiction, in case of such infringement, misuse or breach.

6. Data Protection

6.1 In order to provide access to, control the use of, the Licensed Product, administer the Account and verify that the terms of the License are complied with, Licensor collects and stores personal data provided by Licensee (e.g. name, country, name of company and position, e-mail address, password) on its servers. Licensor will use any such personal data in compliance with the EU General Data Protection Regulation (**EU-GDPR**) and the Swiss Data Protection Act (Schweizerisches Datenschutzgesetz (**DSG**)).

6.2 Licensor may further collect and process personal data from Licensee, if and only to the extent necessary for internal, administrative purposes related to the provision of the Licensed Product to Licensee, including, without limitation, to improve functionality of the Licensed Product, and how software tools are used. To the extent that Licensee's consent is required for certain purposes of processing, as per EU-GDPR/DSG, Licensor will only process Licensee's personal data if such consent has been obtained.

6.3 Licensee expressly accepts that Licensors' servers may be located outside Licensee's country, Switzerland or the EU. Licensor will comply with its legal obligations and, in particular, take appropriate technical, and organizational measures to protect Licensee's data processed against accidental or unlawful loss, access, or disclosure. Licensee agrees that these measures are Licensor's only responsibility with respect to the security and handling of Licensee's personal data and are sufficient in the light of any non-disclosure obligation of Licensor.

6.4 Licensor is allowed to forward to Licensee any requests related to the processing of personal data for Licensee, including, but not limited to, any requests by any data protection supervisory authorities and/or any data subjects. Licensee has a duty to indemnify Licensor for any costs incurred in relation to such requests, as provided for in these GTC.

7. Licensee's Obligations

7.1 Licensee has a duty to, at no cost to Licensor:

- a) not remove any copyright, trademark or other proprietary rights notice of every kind and nature from the Licensed Product, or any other materials originating from or accessible through the Licensed Product;
- b) not frame, model, or mirror any part of the Licensed Product and/or Licensor's servers;
- c) not use any robot, spider, search/retrieval application, or other manual or automatic device, to retrieve, index, "scrape," "data mine", or in any way gather any information or other materials available on or through the Licensed Product, or reproduce or circumvent the navigational structure or presentation of any materials available on or through the Licensed Product;
- d) obtain and maintain all telecommunications, broadband and computer hardware, equipment, and services needed to access and use the Licensed Product, and pay all charges related to them;
- e) keep confidential all Licensor's information and documents not easily available to the public of which Licensor and its employees become aware (in particular the Licensed Product) vis-à-vis third parties and not make the same accessible to third parties in any way whatsoever; and
- f) comply with all applicable laws and regulations.

7.2 The above provisions shall apply mutatis mutandis for Licensee and its employees and agents.

8. Financial Terms

- 8.1 Licensee shall pay any applicable license fees for the use of the Licensed Product, in accordance with Licensor's pricing schedule, as provided to Licensee upon its purchase of the License, and as may be amended by Licensor from time to time thereafter, in its discretion (the **Fees**).
- 8.2 The continued use of the Licensed Product by Licensee is subject to the timely and full payment of the applicable Fees. Licensor may temporarily suspend any license and/or any user credentials issued to Licensee, if applicable, or stop providing any service, if Licensee is in default for payment of any Fees due.
- 8.3 All payments shall be exclusive of any taxes, duties and similar charges payable in respect of the Licensed Product in the jurisdiction where the payment is either made or received. To the extent that any such taxes or duties are payable by Licensor, they will be added to the Fees. If the payment of the Fees is subject to withholding taxes, Licensee shall gross-up the amount of Fees payable so that Licensor receives the Fees net of any applicable withholding taxes. If exemptions, or a reduced treaty withholding rate, are available, Licensor will provide Licensee with reasonable documentary proof to avoid or reduce any withholding tax.

9. Warranties

- 9.1 The Licensed Product is provided AS IS and AS AVAILABLE, except as may otherwise be expressly provided for in these GTC.
- 9.2 The use of the Licensed Product is at Licensee's sole risk.
- 9.3 To the maximum extent permitted by applicable law, Licensor disclaims all warranties of every kind and nature, now or later contemplated with respect to the Licensed Product whether express, implied, or statutory, including, but not limited to any warranties of merchantability, fitness for a particular purpose, quiet enjoyment and non-infringement of third-party rights.
- 9.4 In particular, without prejudice to the generality of the foregoing, Licensor does neither represent nor warrant that the functionality of the Licensed Product will meet Licensee's requirements, that the operation of the Licensed Product will be uninterrupted or error-free, that any errors in the Licensed Product will be corrected, that it will ensure continued compatibility of the Licensed Product with any third-party products, even if they are compatible with such third-party products upon the granting of the License, or at any given moment before or after, that the Licensed Product will always be available and remain available and/or unchanged under these GTC, or any other terms and conditions under which Licensor may provide the Licensed Product.

10. Limitation of Liability

- 10.1 Licensor's liability under these GTC, whether in contract, tort or any other theory of liability of every kind and nature, now or later contemplated, is excluded to the maximum.
- 10.2 To the extent permitted under applicable law, Licensor disclaims any liability of every kind and nature, now or later contemplated in case of Licensee's use of the Licensed Product, other than as specifically allowed by Licensor per these GTC, for simple negligence, as well as for any other damages or losses of every kind and nature, whether or not Licensor has been advised of the risk involved, including, but not limited to, related to the loss of use, interruption of business, loss of actual or anticipated profit, loss of revenue, loss of anticipated savings, loss of opportunity, loss of goodwill, loss of reputation, loss of, damage to, or corruption of, data, or any other indirect, special, incidental, exemplary, or consequential damages or losses of every kind and nature, now or later contemplated, regardless of the form of action, whether in contract, tort, strict liability, or otherwise.
- 10.3 In no event can Licensor's total liability towards Licensee exceed the amount of the Fees actually paid by Licensee under these GTC.
- 10.4 The exclusions and limitations under this Section 10 extend to the Licensor's directors, officers, employees, agents, representatives and auxiliaries.

11. Indemnification

- 11.1 Licensee has a duty to fully and effectively, on demand, to the broadest extent allowed by applicable law, defend, hold harmless from, and indemnify, Licensor, its directors, officers, employees and auxiliaries (**Affiliates**), from and against any and all liability, losses, claims, causes of action, proceedings, costs, liens, encumbrances, damages, and expenses of every kind and nature, now or later contemplated (**Claims**), including, but not limited to, actual attorney's fees, and all costs, resulting, in whole or in part from, or related to, Licensee's use of the Licensed Product other than as permitted under these GTC or not strictly in accordance with any documentation provided for the Licensed Product, and for any and all Claims brought against Licensor by any third parties, related, in whole or in part, to Licensee's use of the Licensed Product.
- 11.2 In case of any Claims made against Licensor, and/or its Affiliates, in whole or in part in relation to Licensee's use of the Licensed Product, Licensor will (i) inform Licensee of such Claims without undue delay; Licensee has a duty to provide to Licensor all the assistance required in relation to that Claim and has a duty to immediately upon demand reimburse Licensor for any payments made by or on behalf of Licensor with respect to any Claim to which the foregoing indemnity relates; and, (ii) Licensor may allow Licensee to join the defense and/or

settlement of such Claims at its own expense, to the extent permitted under applicable procedural rules, but subject always to Licensor's control of such defense and settlement.

12. Term and Termination

- 12.1 The agreement governed by these GTC enters into force upon any of the following events, whichever occurs first: the (i) download; (ii) installation; or, (iii) use of the Licensed Product by Licensee.
- 12.2 Following its entry into force, the agreement governed by these GTC remains in effect for the duration provided in the License as agreed among the parties, subject to termination in accordance with this Section 12.
- 12.3 Either party may terminate the agreement governed by these GTC at any time, and with immediate effect if the other party is in breach of any of its obligations pursuant to these GTC and such breach, if remediable, is not cured within 10 days of receipt of a written notice (e-mail sufficient) to that effect from the party not in breach. Licensor may also terminate the agreement pursuant to Section 13.2.
- 12.4 Upon termination of the agreement governed by these GTC the License automatically and instantly becomes void, Licensee has a duty to immediately and permanently delete any part of the Licensed Product installed on any device and on its IT environment, and to cease any use of the Licensed Product, in whole or in part, and any unpaid Fees become due immediately. Subscription Fees paid in advance will not be reimbursed, except if the agreement governed by these GTC is terminated (i) by Licensor for a reason not imputable to Licensee; or (ii) by Licensee due to a breach of Licensor's obligations or in relation to an amendment of these GTC pursuant to Section 13.2, in which events paid subscriptions Fees for the unused period will be reimbursed on a *pro rata* basis.

13. Miscellaneous

- 13.1 *Reference.* Licensor has the right to mention Licensee as a customer, on its website and on other promotional materials, and to use Licensee's name and/or logo to that effect.
- 13.2 *Amendment.* Licensor may amend these GTC at any time by written notice (e-mail sufficient) to Licensee. Any amendment becomes effective immediately, or as otherwise indicated in

Licensor's notice to Licensee. If Licensee does not accept any amendment notified by Licensor, within 10 business days of Licensee's receipt of that notice, its sole remedy is to terminate the agreement governed by these GTC, in accordance with Section 12.3. Failure by Licensee to either accept or reject any amendment within those 10 days, constitutes acceptance of the amendment.

- 13.3 *Severability.* If any provision of these GTC is held to be invalid or unenforceable for any reason, Licensor will replace such provision with a valid and fully enforceable provision reflecting the original intent of the parties to the fullest extent possible. In any event, all other provisions of the agreement governed by these GTC remain valid and enforceable to the fullest extent possible.
- 13.4 *No Waiver.* The failure of either party to enforce any of the provisions of these GTC, or any rights under it, or otherwise available, is in no way a waiver of such provisions or rights.

14. Governing Law and Jurisdiction

- 14.1 *Governing Law.* Subject to mandatory applicable law, these GTC are governed by and construed in accordance with Swiss substantive law, at the exclusion of its conflict of laws provisions.
- 14.2 *Jurisdiction.* Any dispute or controversy arising out of or in relation to these GTC and/or Licensee's use of the Licensed Product, is subject to the exclusive jurisdiction of the competent courts at the principal place of business of Licensor. Notwithstanding the preceding, nothing in these GTC prevents Licensor from seeking injunctive relief, or any other remedy, available in any jurisdiction in case of any infringement of its intellectual property rights.
